### ABOUT YOUR PROCEDURE BILL

Digestive Health Physicians is pleased that you have chosen us to provide your medical services. In our endeavor to provide quality care to our patients, and to control billing cost, we would like to make you aware of the following information regarding your procedure bill. There are **four fees** involved in this process.

**1. Physician Fee**

**2. Facility Fee**

**3. Anesthesia Fee**

**4. Pathology Fee**

**If you have Medicare and a Supplemental Insurance:** You will NOT be called or asked to make a prior payment for your procedure. We will bill both insurance companies. Any unpaid balance remaining you will be sent a bill. Bring your insurance cards and photo ID the day of your procedure. We will provide a written estimate upon your request.

**If you have No insurance, or if you only have Medicare and no secondary coverage, or you have a group insurance plan, or a commercial insurance plan:** You will receive a phone call from Digestive Health Physicians before your procedure to discuss the estimated amount that will be due. If you do not return our phone call, your procedure may be canceled. Credit/debit card payments can be called to our office anytime after you receive the estimated amount and before your procedure. If we do not hear from you, we will call you the day before to collect. If paying by cash or check you need to bring this on the day of your procedure.

**Digestive Health Physicians** – Will call you regarding the physician fee, and your anesthesia fee.

Depending on which surgery center your procedure will be performed, you will be notified by that surgery center's billing office. There is a facility fee for this procedure. This is a separate fee from the physician fee, the anesthesia fee and/or the pathology fee.

**Laboratory** – If biopsies are taken, or polyps are removed, during your procedure, you will receive a bill from the pathology company. Several labs are used depending upon your individual insurance coverage. Please call the number on the bill you receive if you have any questions.

We appreciate the opportunity to provide your medical care. Our staff is always available to answer your questions. You may reach us at any time by calling 239-939-9939 immediately press 1 then immediately press 2 then you will press 1 if your last name is A-L or press 2 for accounts M-Z.

Your procedure may be delayed or canceled if you do not pay in advance or bring with you all payments; the physician's payment, anesthesia payment, and the facility payment. Payments need to be made by separate checks or by a credit card.
